

Skerne and Wansford Parish Council



Minutes of a meeting of the Skerne and Wansford Parish Council which took place on Tuesday March 15th 2022 in Wansford Village Hall at 7.30pm.

- 1 **Present:** Councillors Catherine Bristow, Lee Cawthorne, Charlie Dewhirst, Mark Padgett (Chair), Neil Robson and Ward Councillor Jane Evison.
- 2 **Apologies:** Councillors Ann Kitching and Leonie Jordan.
- 3 **Public session:** A member of the parish expressed their opinion on what the Harmony Energy Fund might be used for; renovation of the brick bus shelter in Wansford and renewable energy options for both the villages were discussed.
- 4 **Declarations of interest:** None
- 5 **Confirmed:** that the minutes of the meeting held on 10th March 2022 are signed as a true and correct record, proposed Cllr Bristow, seconded Cllr Dewhirst.
- 6 **To dispose of any business remaining from the previous meeting and, if necessary, decide on a course of action:**
 - i Harmony Energy Community Fund Contribution – Councillors discussed possible projects and all agreed that the CEO of Harmony Energy would be invited to give a short presentation at the Annual Parish Meeting and host a questions and answers session. **Action: Clerk to contact Harmony Energy and arrange for a speaker to attend the Annual Parish Meeting.**
 - ii Lisset Wind farm Grant – The Clerk reported that no progress had been made due to confusion over who to contact at the East Riding of Yorkshire Council (ERYC). **Agreed: Cllr Evison would make enquiries at the ERYC and feedback to the clerk to follow up.**
 - iii Speed Gun Volunteers – Skerne residents organising the volunteers had requested £300 for the equipment that would need to be purchased from Humberside Police. Councillors suggested that should the volunteers raise £150 that the remaining £150 would be funded by the SWPC. **Resolved: That the SWPC would provide funding of £150 to the Skerne Speed Gun Volunteers for the purchase of equipment from the Humberside Police.** Proposed Cllr Cawthorne, seconded Cllr Robson
 - iv Speed Survey for Wansford – The Clerk reported that a survey had been requested. A detailed response had been received from the ERYC explaining that due to how the surveys are organised that a survey would likely be carried out in September 2022.
 - v Queens Platinum Jubilee – The Clerk reported that a meeting had been held in Wansford but that Skerne had organised a separate meeting; this would cause problems should either group wish to apply for the Jubilee Grant available from ERYC; the time frame was also highlighted. **Noted: That Cllr Bristow would contact those involved and invite everyone to a meeting to organise events for the whole parish. Action: Clerk to submit an application for funding from the ERYC once costings had been received.**
- 7 **Planning:**
 - i. **Resolved:** To ratify no comment for planning applications: **20/00217/PLF** Erection of poultry house and feed bin to replace poultry house destroyed by fire (House 4); **22/00216/PLF** Erection of poultry house and feed bin to replace poultry house destroyed by fire (House 2).
 - ii. **Noted:** Amendment to planning application **21/04521/PLF** Amendment to the description of single storey side extension.
- 8 **Finance:**
 - i **Noted:** Bank balances of £15190.79 (current account) and £1,281.69 (savings account) as at 28 February 2022.
 - ii **Resolved: To pay the Clerk's net annual salary for the year ending 31st March 2022.** Proposed Cllr Robson, seconded Cllr Dewhirst.
 - iii **Resolved: That the Clerk would apply for a debit/credit card for SWPC.** Proposed Cllr Padgett, seconded Cllr Dewhirst.
 - iv **Resolved: That the SWPC would move to online banking.** Proposed Cllr Cawthorne, seconded Cllr Padgett.


